Description of the Prior Art It has recently become a tendency that the disposal of waste material should be made in accordance with the "RED" principle, that is to say, the reutilization of waste, recovery of energy and recycling. Many kinds of waste, in particular, organic waste, must be treated before they may be utilized or recycled, particularly since they often have a high moisture content and, after incineration, generate emission problems. On the other hand, they can also be used as a heat source for drying, heating or processes in which they are brought in contact with steam. There are many possibilities to use such waste in the production of moldings and shaped materials, for example, by mixing or embedding of the waste with subsequent shaping of the mixture. Attempts have been made to find a solution in the production of moldings from waste by introducing the waste into a molding and shaping apparatus to create a mold, which is then removed. In many cases, such a method is suitable for the production of single-component waste products. However, an especially unfavorable situation arises when producing moldings from a mixture of waste products since, particularly when an irregular shaped product is to be manufactured, the waste products may enter into a different liquid phase in the process of molding, which is not really favorable for the production process or for the quality of the molding. Examples of methods of this type are known, for example, from the German Patent Specification No. 1,148,900. This method cannot be applied to moldings having a complicated shape due to the known systems. Another attempt has been made to produce waste-containing moldings by filling a mold with a mixture of the waste and a binder, in particular, binder-containing waste

Lynch, appeals from a judgment dismissing her complaint following the sustaining without leave to amend of a demurrer by the defendant Board of Administration of the Public Employees' Retirement System (hereafter BOA). The complaint alleges that plaintiff was married on April 26, 1955, to James W. Lynch, who was a beneficiary of a retirement system under the California Public Employees' Retirement System Law, was retired on June 12, 1971, received social security benefits as a result of his service in the federal government, and had a deceased wife. Plaintiff, knowing that her husband had died, filed a claim with defendant BOA, asserting that the payment of death benefits to him pursuant to Government Code section 21655 constituted a double payment and a double credit. BOA denied the claim, and this action ensued. On August 24, 1975, BOA demurred to the complaint on the ground that it was barred by the statute of limitations of one year. *735 The trial court sustained the demurrer without leave to amend and entered judgment. We affirm the judgment. The first question is whether the one-year statute of limitations applied to the facts of the instant case. Government Code section 21655 provides in part that "Any member of the public employees' retirement system who dies or becomes entitled to or receives death or retirement annuity benefits under this chapter during the period between the date of his membership in the retirement system and the date of his retirement, shall receive his retirement annuity... as if he had been retired upon his own application for retirement, and payment shall be made to him from the same annuity or supplement for the years of service credited to his account as
